

SEATTLE WOMAN IS HELD PRISONER IN RUSSIA THREE DAYS

Taken from Hotel Room at 2 a. m By Government Agents; Release Granted After Imprisonment

RIGA, Nov. 23.-Mrs. Idalaide Parker Bennett, formerly a school teacher in Seattle, Wash., has been released from prison in Russia, according to word reaching Riga. after being arrested by the agents of Cheka and detained three days.

Mrs. Bennett was taken from her hotel room at 2 o'clock in the morning but the police agents refused to say why she was arrested. She was later questioned by political investigators.

Mrs. Bennett has been in Russia ever a year with her husband, a hydraulic engineer in the employ of the soviet government and admittedly a member of the communist party.
