SPECIAL MEETING OF THE BOARD OF DIRECTORS

CHICAGO, MILWAUKET & ST. PAUL RAILWAY COMPANY OF MONTANA.
(Held August 31, 1906.)

"Chicago, Illinois, August 31st,1906.


