The schedule shown in FM/TM dated May 16, 1983 with respect to dates set by the Interstate Commerce Commission in our reorganization proceedings has been modified slightly.

At a prehearing conference, held June 9 at the Commission's Washington, D.C., headquarters, the Chicago and Northwestern Transportation Company requested, and was granted, a two week extension to prepare its responsive applications.

The date set earlier by the ICC - July 13 - was extended to July 27, 1983. As a result, the hearing date - previously scheduled for August 8 - was pushed back to August 15, 1983.

The rest of the schedule remains unchanged. A number of issues were resolved at the prehearing conference and we would expect that the tight time schedule previously established for the proceedings will be followed.


