

ARTICLES OF INCORPORATION
OF THE
GREAT FALLS WESTERN RAILWAY COMPANY.

We, the undersigned, desiring to form a corporation under the laws of the State of Montana, do hereby subscribe and acknowledge the following Articles of Incorporation:

I.

The name of the corporation shall be, GREAT FALLS WESTERN RAILWAY COMPANY.

II.

The purpose for which said corporation is formed is, to construct, maintain and operate a railroad for the carriage of passengers, freight, mail and express; and a telegraph and telephone line in connection therewith. The names of the counties and state where the terminals of said road are to be located, and the counties through which said railroad shall pass, and the general route of said railroad, are described as follows:

Beginning at a point of connection with the railroad of the Chicago, Milwaukee & St. Paul Railway Company, upon Section Thirty (30), in Township Twenty-one (21) North, Range One (1) East, Principal Meridian of Montana, in Cascade County, thence in a generally southwesterly and westerly direction through the Counties of Cascade, Lewis and Clarke, and Powell, to a point of connection with the railroad of the Big Blackfoot Railway Company, upon Section Thirty (30), Township Fifteen (15) North, Range Thirteen (13), West of said Meridian, in said Powell County, all in the State of Montana, the estimated length of which proposed railroad is one hundred sixteen (116) miles; and such branches and extensions of said railroad as may be hereafter authorized.

III.

The place where the principal business of said corporation is to be transacted is the City of Great Falls, in the County of Cascade, and State of Montana.

IV.

The term for which said corporation is to exist is forty (40) years.

V.

The Board of Directors of said corporation shall be five (5) in number, and the names and residences of those who are appointed for the first three (3) months, and until their successors are elected and qualified, are: C. A. Goodnow, Evanston, Illinois; J. D. MacVicar, Great Falls, Montana; James O'Grady, Great Falls, Montana; P. H. Scanlan, Great Falls, Montana; C. L. Whiting, Lewistown, Montana.

VI.

The amount of the capital stock of said corporation, and the amount necessary to construct the said railroad, is One Million Dollars (\$1,000,000), and it is divided into ten thousand (10,000) shares of One Hundred Dollars (\$100) each.
